Cynthia McConville - Forest and Bird Golden Bay

Ms McConville proposed a prohibition on highspeed watercraft on the Takaka river be established with signage installed on the Waitapu Bridge over Takaka river.

William Wallis - Floating Launching Dock

Mr Wallis proposed installation of a floating launching dock, and tabled images of a similar construction at Motueka which he hoped would be considered for the recreational launch ramp at Tarkohe.

Points raised by Mr Wallis included:

- Cost increases to recreational users, with limited facilities available for their use;
- Charges which had risen beyond inflation;
- Staff had promised a toilet and ablutions block would be installed by Christmas, this didn't happen.

8 REPORTS

8.1 Board Report - March 2024

The Board discussed this report and were encouraged to seek staff guidance on the proposed wetland regeneration project spearheaded by the Friends of East Mohua.

Harbourmaster Update

The recently appointed Harbourmaster (P Renshaw) introduced himself to the Board with an introduction of himself and his role, which holds responsibility for all navigational safety over the entire district, from Kahurangi Point to Tahunanui Estuary, to 12 miles out.

In response to questions, Mr Renshaw

- confirmed Port Tarakohe is managed by the Port Manager, with safety concerns directed to the Harbourmaster;
- encouraged people to provide photos and videos of any complaints or concerns around safety on the water;
- explained the potential to establish a bylaw to require registration of water vessels.

Golden Bay Museum Mural

Concern was raised about cyclist and pedestrian safety in three locations in Golden Bay:

- Motupipi St at the intersection with Commercial Street (SH60);
- Abel Tasman Drive at Port Tarakohe, between the two entrances of the port;
- Reilly Street footpath status, including remarking of faded no parking lines along Reilly Street.
