It was noted that as well as the usual Creative Communities fund, the Creative Communities Festivals fund was also allocated at this meeting. Each fund and allocations are set out below.

The Subcommittee discussed the applications and allocated the following amounts to the Creative Communities Fund:

The Subcommittee declined this application as it was ineligible.

#### **Claire Stanley - Sing 2024**

The Subcommittee considered the amount of \$1,571 was appropriate.
