1. Presentation / Whakatakotoranga

1.1 The Tasman Harbourmaster Office will make a presentation to the Golden Bay Community Board regarding a plan to develop joint agency signage at beaches around the Rohe.

2. Proposal

- 2.1 We propose a single sign be displayed instead of multiple signs from different agencies. These signs will look more attractive than what we currently have, be cost effective as expenses will be split three ways, and provide all information in one place.
- The proposed signs would have the same theme throughout but display information relevant to the specific area.
- 2.3 A joint agency sign has been done well in Akaroa and we are hoping to emulate the same in Tasman. This project would incorporate Department of Conservation (DoC), Ministry for Primary Industry (MPI) and have consultation with Iwi in process.
- 2.4 Joint agency signs would not be possible in all locations. Initial locations include Totaranui, Whanganui Inlet and Awaroa (where there are currently no signs).
- 2.5 The signs are to display information about navigational safety, marine rules/regulations, and fishing rules/regulations.
- 2.6 The Tasman Harbourmaster Office will include this project in our application for funding to Maritime NZ. Applications for this funding opened this week, and we will be submitting our application as soon as we can prepare it.
- 2.7 An assessment of each TDC navigational safety signs will continue until we have considered all signs around Tasman and replaced as needed. This will effectively be a stock take and we will be able to produce a schedule of maintenance from this.
- 2.8 Below are current signs at Parapara, Motueka, Totaranui, Collingwood, and the joint agency sign at Akaroa Harbour.

To preserve the history of Mohua Golden Bay for future generations.

Details of the project to be funded

The Museum wish to install a mural with a historic flavour to be affixed to the Museum building. The image depicts what teh Pioneer tram may have looked like at the turn of the century. It has been created in an impressionist painter's view by local artist Chris Finlayson. The Pioneer tram was in use for approximately 24 years in the early 1900s and ran from East Takaka to Waitapu Wharf. Commercial Street was on the route to the wharf, and ran past directly opposite the old historic Post Office building which forms part of the Museum's buildings. the image size is W2400mm x H2000mm and would be printed on two ACM panels and affixed to the corrugated iron on the South facing wall by the current entrance to the Museum. ITM have been approached to install the panels and have advised that the best way would be to rivit the panels into the iron with rubber washers between for waterproofing. This way would also enable the panels to be removed relatively easily if ever required.

Tēnā koutou Golden Bay Community Board

At a meeting of the Board of the Golden Bay Museum Society Inc held on 13 March 2024 it considered a proposal for a mural with a historic flavour to be affixed to the Museum building. The Board are in favour of proceeding with this proposal, it will provide an eye-catching piece showcasing a part of Mohua Golden Bay's history, and hopefully make the outside of the museum buildings a bit more interesting.

The image depicts what the Pioneer tram might have looked like at the turn of the century. It has been created in an impressionist painter's view by local artist, Chris Finlayson. The Pioneer tram was in use for approximately 24 years in the early 1900s and ran down Commercial Street from East Takaka to Waitapu Wharf.

A panel with appropriate wording will be displayed alongside the mural – wording would be something similar to:

"Pioneer on Commercial St".

A depiction of the tram, created in an 'Impressionist' style from the 1900's era.

Artwork donated by C.J.Finlayson & sponsor

Attached is the artists' impression of what the mural would look like on the building. Image size is W2400mm x H2000mm, it would be printed on two ACM panels and affixed to the corrugated iron at the front of the building.

Costings as follows:

\$1058 +GST printing onto ACM panels

\$45.00 +GST set up

Freight – still to be established.

\$97.90 – affixing to the corrugated iron by ITM.

Total cost \$1200.90 +GST – plus freight and signage.

I have spoken with ITM about the best way to affix the panels to the building without causing water egress into the building and providing a seamless view of the image from the road frontage. They advise the best way would be to rivet the panels into the corrugated iron with a rubber washer between to form a waterproof seal. This will also enable reasonably easy removal if ever required.

Chris Finlayson has advised that he is prepared to donate towards the cost of this project and the Museum will be able to put finances towards this as well. If the Golden Bay Community Board can assist financially towards this project, it would be most appreciated.





5. Collingwood beach access

- 5.1 A letter was received from P Watts regarding the placement of rocks at a beach vehicle access point off Beach Road at Collingwood Beach, which was forwarded to staff for comment.
- 5.2 Staff advised the beach access point in question was located on Department of Conservation property, and that council was not involved in the placement of the rocks at this access point, which was relayed to Ms Watts.

6. Better Off Funding

- 6.1 Following a recent decision from Cabinet, Council have now been requested to redirect any unspent Better Off Funding (BOF) to increase investment in water infrastructure or to help establish new water services delivery organisations.
- 6.2 This directive means BOF will no longer be available for a feasibility study for the proposed Bike Park on Fonterra land at Motupipi Street.
- 6.3 The directive would not impact the Motupipi Street shared path which is under construction.

7. Long Term Plan submission

- 7.1 The Board met to collate a submission to the Long Term Plan (LTP) Consultation, which was submitted prior to the closing date.
- 7.2 Board Chair Abbie Langford spoke to the Board submission (attachment two) at the LTP Hearing in Tākaka on 9 May 2024.

8. Special Projects Funding

- 8.1 The Board have a total budget of \$37,747 available in the Golden Bay Community Board Special Projects fund, and have identified six potential projects for funding from the Golden Bay Community Board Special Projects Fund.
 - 8.1.1 Christmas Decorations for Commercial St, Tākaka and Tasman St, Collingwood Approximately \$20,000
 - 8.1.2 Welcome to Tākaka/Golden Bay Mohua sign Approximately \$10,000
 - 8.1.3 Contribution towards Pakawau playground development Approximately \$20,000
 - 8.1.4 Funding for construction of a tunnel house for the hanging basket volunteer group Approximately \$7,000
 - 8.1.5 Replacing the wooden fence outside 44-50 Commercial Street (Dangerous Kitchen & Bay Takeway) Approximately \$15,000
 - 8.1.6 Upgrade existing CCTV network in Tākaka and Collingwood Approximately \$20,000

01 FINANCIAL SUSTAINABILITY

The Golden Bay Community Board support Preferred Option A.

Should Council be considering a reduction in community services, the Community Board support the continued funding for Libraries and Community Partnerships at the current levels of service. The Board does not support the sale of Council owned revenue generating assets.

02 TRANSPORT

02.1 SEALED ROAD MAINTENANCE

The Golden Bay Community Board supported Preferred Option A.

02.2 PUBLIC TRANSPORT

The Board supported Preferred Option A:

- a) expanded public transport with increased weekend eBUS services to Motueka, and
- b) the continued funding of community subsidy for Golden Bay residents travelling on Golden Bay Coachlines between Motueka and Tākaka.

02.3 SAFETY FOR PEDESTRIANS AND CYCLISTS

The Board supported Alternative Option B, and supported upgrading the surface of the Tākaka-Pōhara cycleway, including an extension of the shared path through to Port Tarakohe.

The Board also supported the implementation of the speed reduction to 30km/hr in the Tākaka CBD (Commercial Street) and around the Collingwood Area School (Orion and Excellent Streets) as part of the Active Transport Strategy, and would like to see this activated.

03 CLIMATE CHANGE AND RESILIENCE

The Board supported Alternative Option B, noting the minor cost increase in relation to Preferred Option A would improve community resilience to Climate Change events.

04 INVESTING IN COMMUNITY FACILITIES

The Board supported Preferred Option A, including the use of Golden Bay Reserve Funds to support the funding of the Motueka Community Swimming Pool.

Other comments about Choice 4 Investing in Community Facilities?

The Board requested the proposed Takaka Skate Park development on Motupipi Street be given consideration for funding, noting a feasibility study had been identified for funding through the Better Off Funding scheme.
