#### 3.2 Policy on Dangerous Dams, Earthquake-prone Dams and Flood-prone Dams -Deliberations

Community Policy Advisor, Amy Smith, presented the report, and gave a brief summary of the legislation and background. She outlined the consultation, noting that there had been limited responses, and that this only affected dam owners. There had been one submission that suggested some aspects of the policy were ambiguous. The wording in the draft policy was to maintain a database for 'all' dams, the word 'all' caused confusion and staff recommended removing 'all' from section of 3.1 of the policy. She noted that the Council was required to give a copy of the policy to the Chief Executive of the Ministry for Business, Innovation and Employment (MBIE)
