He answered questions on feedback from Te Whatu Ora, alcohol sponsorship on players' clothing, impact of the amendment to the policy and existing clauses covering panel's expectations.

Councillor Daikee moved, seconded by Mr Shaw, an amended officer's recommendation with additional reference to include of 4.8.1.3. Councillor Daikee explained the purpose of this motion was to accommodate low alcohol beverages in the venue during international games.
