3 PUBLIC FORUM

3.1 Bruce Collings – Salisbury Bridge Reinstatement Group

Mr Collings spoke to his tabled speaking notes, regarding the Salisbury Swingbridge Reinstatement Group. The group had been unsuccessful in sourcing central government funding to replace the historic swingbridge. Mr Collings was thanked by Chair Langford for all his work in this area. 8 REPORTS

8.1 Special Projects Fund

The Board discussed the community feedback received and considered the assorted projects for funding.

The Board noted:

- the tunnel house project was really about the hanging baskets, and that there were unanswered questions around who would drive the tunnel house project;
- Pakawau playground had been identified by staff but was low on the priority list;
- Special Projects had not been allocated for some time, which had led to a build-up of available funding;
- All options would be dependent on a feasibility study.

The Board also noted the alternative suggestions, which would be valuable for identifying projects for future funding rounds; noting suggestions had included fencing the Tākaka Playground; a Disc Golf course; and repair of the Rockville Hall roof.

The Board noted the fund was for Special Projects, and there was no desire from the Board for the fund to be used for operational costs.

Contribution towards upgrading Rockville Community Pool

Replacing the wooden fence outside 44-50 Commercial Street (Dangerous Kitchen & Bay Takeaway)

Contribution towards Pakawau playground development

Funding towards construction of a tunnel house for the hanging basket volunteer group

- notes that staff feedback on the scope and feasibility of the Special Projects 2024-2025 proposed for funding will be provided at the Golden Community Board's 12 August 2024 meeting; and
- 6. agrees that the Golden Bay Community Board Special Projects 2024-2025 funding will be confirmed at the 12 August 2024 meeting, following consideration of staff feedback.
