#### 7.1 Fire and Emergency New Zealand - Te Waikoropupu Resilience Project

Fire and Emergency New Zealand (FENZ) Regional Community Readiness and Recovery Advisor, Darren Crawford, and John Ayling from Te Waikoropupu Springs Resilience Project, gave a presentation on the joint project between FENZ, the Department of Conservation and Manawhenua ki Mohua to reduce the risk of wildfire at Te Waikoropupu Springs.
