# 7.3 Quarterly Climate Change Update

Senior Climate Change Advisor (B Lewando), Senior Community & Reserves Policy Advisor (A Gerraty), and Community Policy Advisor (C Budai) presented this item and the report was taken as read.

Questions and discussions included:

- Explained and discussed the new government direction on the application of the five pillars (resilient infrastructure, strengthening credible markets for emission trading scheme, renewable energy, develop innovative technologies, balanced approach to climate change).
- Emphasised the need to engage younger generations to develop and plan for climate change programmes. Noting that collaboration is vital to ensure that there

- are effective responses and planning to mitigate future damage through welldeveloped education programmes.
- Funding arrangements for climate adaptation were described and discussed in the context of the broader education system.

- Emphasised that the survey is voluntary and the public cannot be compelled to complete it. Work is ongoing to make acceptance more attractive to public for response. Innovation in that area is ongoing, as the work to achieve the non-skewing of data.
