7.1 Representation Review - Submissions Hearing and Deliberations

Hearing of Submitters

Graeme Helleur (33727) - did not attend.

**Matthias Schaeffner –Tasman Democracy (33818)** - Mr Schaeffner spoke about communities of interest and fair representation for the future. He suggested that the Moutere-Waimea Ward should be merged with other wards as he believed the community of interest for Moutere was in the Motueka Ward.

**Bruce Struthers (34131)** – Mr Struthers suggested that the Council should have used the most recent census data for the representation review. He also suggested that over representation of elected members was preferable to under representation.

The meeting was adjourned at 10:05am and reconvened at 10:15am.

### 8 REPORTS

### 7.1 Representation Review - Submissions Hearing and Deliberations

Group Manager – Service and Strategy, John Ridd and General Counsel, Leith Townshend, presented the report. Mr Ridd tabled the following staff comment in relation to item 5.10.2 of the report, to be included in the Representation Review proposal:

(5.10.2) Disestablishing the Moutere-Waimea Ward and that parts of that ward are added to either the Motueka or Richmond Ward.

"Options such as this for the Moutere-Waimea Ward were discussed during earlier stages of this review, but not progressed on the basis that disestablishing the ward would divide existing communities of interest. The ward comprises a well-established network of settlements which are serviced by local facilities and amenities, and supports a strong local network of community associations. The ward's settlements are predominantly rural and coastal in nature, and do not naturally share common interests with the more urban centres of Richmond or Motueka".

It was clarified that the Council was required to publicly notify its final representation review proposal by 28 October 2024, and that after that date, any feedback on the proposal was collated by the Council and provided to the Local Government Commission for consideration in its determination.

- 2. receives and considers <u>92 submissions</u> on the Council's Initial Representation Review proposal received by 2 September 2024; and
- 3. agrees to accept one late submission received after 2 September 2024; and
- 4. adopts under sections 19H and 19J of the Local Electoral Act 2001, the following Final Proposal for Tasman District Council for the triennial elections to be held in October 2025 and any subsequent elections/polls held thereafter until altered by a subsequent decision:
  - I. the Council will comprise a Mayor, who is elected at large, and 14 Councillors elected by wards:
  - II. the Tasman District be divided into five general wards and one Māori Ward as per the appended maps (Attachments 4 and 5 to the agenda report), with Councillors being elected as follows;
    - Richmond General Ward four councillors
    - Motueka General Ward three councillors
    - Moutere/Waimea General Ward three councillors
    - Golden Bay General Ward two councillors
    - Lakes/Murchison General Ward one councillor
    - Te Tai o Aorere Māori Ward one councillor
  - III. the population (based on Statistics NZ estimates as at 30 June 2023) that each member will represent is as follows:

IV. that there be two communities which will be represented by a community board (Attachment 6 to the agenda report) as follows:

Golden Bay Community Board	Area covered by the present Golden Bay Ward boundaries.
Motueka Community Board	Area covered by the present Motueka Ward boundaries.

V. Golden Bay and Motueka communities will each elect four members. They will not be subdivided for electoral purposes. Following the elections, elected Ward members will be appointed to the Boards by the Council, as follows:

Golden Bay Community Board	Two members to be appointed from the Golden Bay Ward and/or the Te Tai o Aorere Māori Ward
Motueka Community Board	Three members to be appointed from the Motueka Ward and/or the Te Tai o Aorere Māori Ward.

- VI. that, following resolution CN23-09-6 and RCN24-10-2, Tasman District Council has established a Māori Ward and proposes that the Māori Ward be named 'Te Tai o Aorere Māori Ward'; and
- 5. agrees that the Golden Bay General Ward be treated as an isolated community and be exempt from complying with S19V(2) of the Local Electoral Act 2001 on the grounds provided under S19V(3)(a) that non-compliance with S19V(2) is required for effective representation of isolated communities of interest within this ward, for reasons including:
  - the ward has previously been recognised by the Local Government Commission as an isolated community in representation reviews since 2007;
  - the area's geographical separation from the rest of Tasman District;

- limited road access, with the main road access (SH60 Tākaka Hill) frequently susceptible to closure due to weather events, slips etc;
- distance and travel time to the Council offices, affecting the Council's capacity to provide services to the community;
- the area's character as a summer destination where the small permanent population is significantly increased by visitors during the holiday season.
- 6. agrees that the Moutere/Waimea General Ward be exempt from complying with s19V(2) of the Local Electoral Act 2001 on the grounds provided under S19V(3)(a):
  - that compliance with S19V(2) would limit effective representation by dividing communities of interest between wards.
- 7. agrees that the Richmond General Ward be exempt from complying with s19V(2) of the Local Electoral Act 2001 on the grounds provided under S19V(3)(a):
  - that compliance with S19V(2) would limit effective representation by dividing communities of interest between wards.
- 8. notes in accordance with S19K(2) of the Local Electoral Act 2001, that the proposal includes the following changes to existing representation arrangements, for the reasons set out below:
  - the addition of the Te Tai o Aorere Māori Ward to provide a way for Māori within the District to contribute to decision-making and have representation at the Council;
  - the addition of one councillor to represent the Te Tai o Aorere Māori Ward to enable the creation of the Te Tai o Aorere Māori Ward and improve effective representation for Māori within the District; and
- 9. agrees that public notice be given of the Council's Final Representation Proposal in Newsline, inviting appeals from those people who submitted to the Initial Proposal, and objections from any person who objects to the final proposal (if different from the initial proposal), for a period of at least one month; and
- 10. notes that staff will advise all submitters on the Initial Representation Proposal of their right to appeal on matters contained in their submissions; and
- 11. notes that if the Final Proposal:
  - does not meet legislative requirements in terms of S19(V)ii of the Local Electoral Act 2001; and/or
  - is subject to appeal or objection; and
- 12. that appeals, objections and other relevant information is required to be forwarded to the Local Government Commission for final determination of representation arrangements for the 2025 triennial elections, and for further elections, including by-elections, until next reviewed.
