8.2 Motueka Community Board Report - October 2024

Chair Graham presented the report, which was taken as read.

Questions and discussions included:

- Residential development in Motueka it was explained that only approved properties within certain zones could be added to wastewater supply system to avoid overloading and negative environmental impacts.
- Importance of working with the community to find appropriate solutions the role of the Board in working through solutions was clarified, along with the role that the Board has in facilitating positive outcomes for the Motueka community.
- 8-week rule discussions and work to date in this area was discussed. It was emphasised
 that extending the 8-week rule required thorough analysis to manage risk and unintended
 consequences.
- Resource Management consenting processes it was explained that a holistic approach is
 used which includes the environment, building design and location, community views,
 council planning, and required infrastructure.
- Managing public expectations clear and deliberate communication between the Council, contractors, and the public was emphasised to achieve this.
