6 REPORTS

6.1 Update from the National Emergency Management Agency

National Emergency Management Agency (NEMA), Senior Regional Emergency Management Advisor, James Lamb, presented the report on behalf of Mike Gilhooly (NEMA), and provided an update on the new Emergency Management Bill and the Emergency Management Improvement Programme (MSIP), both of which were currently sitting with the Minister for Emergency Management and Recovery, and would be open for public consultation on 15 April 2025 for one month, with the Bill scheduled to be introduced to the House in October 2025.

Questions and discussions included:

- Conversations progressed with the Minister of Emergency Management and Recovery regarding extending the Local Government New Zealand (LGNZ) fast tracked process into the recovery phase (the special legislation relating to Cyclone Gabrielle was used as an example).
- The consultation process on the Emergency Management Bill

Action:

Joe Kennedy to follow up with Jame Lamb (NEMA) to confirm the consultation process and provide more details on the opportunities for input from the Civil Defence Emergency Management (CDEM) group and key stakeholders on the Emergency Management Bill, including pre-introduction and Select Committee processes.

6.3 Report of the Nelson Tasman Emergency Management Office

Mr Kennedy presented the report.

Questions and discussions took place around:

- The current weather situation in the region
- A heightened focus on hydrology due to media coverage and potential for significant rain in the region – areas at risk and impacts – regular updates were being provided

- Recent events in the region the Lee Valley fires were noted
- Social media following growth was noted
- Continuous improvement of the reporting dashboard
- Participation in the Nelson Tasman CDEM Group Exercise activity in December 2024
- The need for more trained personnel, particularly in the context of Civil Defence Centres
- Key risks, including EMT staff leave balances
- NEMA and Controllers:
 - who chooses the controllers and how many there are
 - working on pre identifying controllers before an event takes place (work in progress with EMT)
 - o a national standard for controller development was underway
 - the need for external controllers to familiarise themselves with the region and staff so they could 'hit the ground running' when an event occurred.

Action: Joe Kennedy to continue developing the orientation/induction pack for external

controllers coming into the region during emergencies.

Action: Joe Kennedy - CDEM office to review and prioritize the 19 recommendations

from the Independent Capability Assessment Report, and explore how CEG members can provide resources to help address and progress the report recommendations with a focus on scenario planning and risk awareness

communication.

Action: Joe Kennedy to change the language of the "Source of Truth" in the project:

Emergency Response Coordinated Source of Truth to avoid potential

misinterpretation.

Action: Joe Kennedy – Emergency Management Team to continue efforts in identifying

and securing agreements for Civil Defence Centres, particularly in areas with

gaps, such as Nelson North.
