3 PUBLIC FORUM

3.1 Marianne Vetterli - Tiny houses

Ms Vetterli spoke regarding her tiny home living experience and that she faced homelessness that she felt was due to actions taken by Council staff. She confirmed that direct neighbours had not objected to her living there, despite the Council's visit that had been triggered by a neighbour's complaint.

She said that since the Council staff had visited she had been left traumatized and unsure why

the Council had taken a heavy handed approach to her situation and that she had suffered panic attacks and felt unsafe since the incident.
