5.1 CONSIDERATION OF 10 JULY 2025 APPLICATIONS

1. Purpose of the Report / Te Take mō te Pūrongo

1.1 To provide the Tasman Creative Communities Subcommittee the opportunity to consider the applications to the Tasman Creative Communities funding scheme and to make decisions on how much funding to allocate to each of the applications.

2. Summary / Te Tuhinga Whakarāpoto

- 2.1 There are three funding rounds per annum closing 10 July 2025, 10 November 2025 and 10 March 2026. The funding is entirely from Creative New Zealand with an annual allocation, paid in two equal instalments in August 2025 and February 2026.
- 2.2 Creative New Zealand have confirmed the allocation of funds for 2025/2026 and indicated that the amount will be similar to previous years, which is \$49,684.
- 2.3 There was \$1,428 carried forward from the 2024/2025 financial year.
- 2.4 The total allocation available for the 10 July 2025 round is the amount of the first instalment (\$24,842) plus the amount left from 2024/25, equal \$26,270.
- 2.5 To ensure sufficient funding across all three rounds, we recommend allocating an amount close to \$17,000.
- 2.6 The Tasman Creative Communities Scheme received 22 applications (see Attachment 1) to the 10 July 2025 round, requesting a total of \$52,428. This funding round is the first of three funding rounds for the current financial year.

4. Background / Horopaki

4.1 Creative Communities is a nationally funded scheme via Creative New Zealand to support community arts and cultural activity. Council's role is to promote community wellbeing through allocating funding to local arts and cultural activities, on behalf of Creative New Zealand.

5. Analysis and Advice / Tātaritanga me ngā tohutohu

5.1 Creative Communities is the Tasman District's funding scheme to support community arts.

The funding comes entirely from Creative New Zealand. This funding, allocated by Creative New Zealand is distributed over three rounds during the financial year. The first round of this financial year is the subject of this report.

- 5.2 We monitor the accountability process for Creative Communities projects by keeping a record of applicants with overdue reports. The following applicants have not yet provided accountability.

 - The Nattery Womens Wellness Series
- 5.3 For the July 2025 funding round we received 22 applications requesting \$52,428.
- To ensure sufficient funding across all three rounds, we recommend allocating an amount close to \$17,000. This aligns with previous July rounds: in July 2024, the Subcommittee allocated \$14,625; in July 2023 \$20,211; and in July 2022 \$17,670.

- 5.5 All applications meet the criteria of the scheme. However, there is some uncertainty regarding the expenses submitted by the Onekaka Hall Homeschool Group. They have requested funding to purchase tools such as an adze and a gouge. While equipment is generally a non-eligible cost, we confirmed with Creative NZ that tools used specifically for producing art are considered differently and are eligible.
- 5.6 Council's role is to allocate the funding for the Tasman Creative Communities scheme via a representative Subcommittee, which understands the needs of our local community. The Subcommittee can assist with enabling the funding to be allocated cost effectively and where it can generate real benefits to the wellbeing of the community. Council's role is to promote community wellbeing through allocating funding to local arts and cultural activities, on behalf of Creative New Zealand. The funding to these groups enables them to also provide local public services to the Tasman community.
- 5.7 Applications must meet one of the following criteria:
 - **Participation** the project creates opportunities for local communities to engage with and participate in arts activities;
 - **Diversity** the project supports the diverse arts and cultural traditions of local communities, enriching and promoting their uniqueness and cultural diversity; or
 - Young people the project enables and encourages young people (under 18 years) to engage with and actively participate in the arts.
- 5.8 These activities should:
 - increase community participation in the arts; and
 - increase the range and diversity, making the arts more attractive and relevant to the various communities that make up the District.
- 5.9 Each Subcommittee member will be allocated a number of applications to review. Their role is to review their allocated applications before the Subcommittee meeting. It is highly recommended that each Subcommittee member calls their allocated applications to gain a deeper understanding of the applicant's project. The Subcommittee members then need to consider whether their allocated applications meet the criteria and, if so, how much funding they recommend allocating.

6. Financial or Budgetary Implications / Ngā Ritenga ā-Pūtea

6.1 The funding for this scheme comes from Creative New Zealand and only passes through Council.

7.2 Option one is recommended.

8. Legal / Ngā ture

- The proposed funding fits with the purpose of local government, where Section 10 of the Local Government Act 2002 states:
 - "(1) The purpose of local government is—
 - (a) to enable democratic local decision-making and action by, and on behalf of, communities: and
 - (b) to promote the social, economic, environmental, and cultural well-being of communities in the present and for the future."
- 8.2 The Council's role in allocating the grant funding is to meet the needs of our local community by assisting community groups with a local public service to the Tasman community in order to deliver improved community wellbeing for present and future generations. In this case we are allocating funding on behalf of Creative New Zealand in order to allocate the funding to areas of local need and importance.

9. Iwi Engagement / Whakawhitiwhiti ā-Hapori Māori

9.1 Creative Communities Grants subcommittee has an iwi representative who guides the decisions on the applications that may be of interest to lwi. In addition, our communications and promotion on the scheme is consistent with the Creative Communities Guidelines, ensuring that all eligible applicants are treated fairly.

10. Significance and Engagement / Hiranga me te Whakawhitiwhiti ā-Hapori Whānui

- 10.1 The decisions sought in this report have a low level of significance. The decisions do not have financial implications, they do not deal with strategic activities or assets; and do not result in changes to the Council's levels of service. The decisions will be of some public interest, although we consider that this interest is likely to be relatively low.
- 10.2 Consultation is not necessary on the decisions to allocate Creative Communities funding due to the low level of significance of the decisions and it is the role of this Subcommittee to allocate this funding.

11. Communication / Whakawhitiwhiti Kōrero

- 11.1 Consultation is not necessary on the decisions to allocate Creative Communities funding due to the low level of significance of the decisions and it is the role of this Subcommittee to allocate this funding.
- 11.2 We publicly notified the opportunity to apply for the funding.

12. Risks / Ngā Tūraru

12.1 The main potential risk to the Council from allocating the funding through the Creative Communities Scheme is that some groups and individuals will not be happy if they are unsuccessful with this funding round, or if they receive less funds than applied for. The Subcommittee can mitigate the risks through clearly explaining the reasons for the decisions to the applicants.

13. Climate Change Considerations / Whakaaro Whakaaweawe Āhuarangi

13.1 No climate change implications are expected from this grant allocation.

14. Alignment with Policy and Strategic Plans / Te Hangai ki ngā aupapa Here me ngā Mahere Rautaki Tūraru

14.1 This grant aligns with Tasman District Council's Long Term Plan 2018-2028 Community Outcome 5: Our communities have opportunities to celebrate and explore their heritage, identity and creativity.

15. Conclusion / Kupu Whakatepe

- 15.1 There is funding in the Creative Communities Scheme for the Subcommittee to allocate.

 This funding is entirely from Creative New Zealand. We have publicly notified the availability of the funding to provide any groups interested in receiving funding the opportunity to apply.
- 15.2 The purpose of this Subcommittee meeting is to determine which applicants should receive funding and how much funding they should receive. The Creative Communities funding criteria needs to be applied to the consideration of the funding requests.

16. Next Steps and Timeline / Ngā Mahi Whai Ake

16.1 The Subcommittee's funding allocation decisions will be advised to applicants following the meeting.
